      - 1. Union has money from Coca-Cola to bring in lecturers to speak about environmental issues. Please contact Lance if you have any suggestions for him.
      - 2. Sustainability team is quite new at the Union and has been making big strides since its inception.
      - They have been reworking the recycling stream in the Union, increasing sustainability messaging, and implemented a pilot composting program that is not back of house.

- 3. City of Fayetteville Climate Action Plan
  - a. Peter Nierengarten, City of Fayetteville Environmental Director
    - The city has implemented a new Climate Action Plan, and update from their 2018 version.
    - ii. The 2018 version focused on emission reduction in a couple of areas and it had a 40% GHG emission reduction goal by 20-30% and 80% goal by the year 2050.
    - iii. Once the city brought their new wastewater treatment plant and solar array online, they saw a 70% reduction in emissions but were using 13% more energy. Which really helps illustrate is the decoupling of energy use and carbon emissions because of investments in clean energy, the clean energy investments we made in our 25 MW solar array projects

that are wastewater treatment plants, you've got to give some of the credit to our utility companies who have been greening the supply of electricity that's coming to the city.

- iv. With significant progress being made, the new Climate Action Plan's goal is to be net zero emissions by 2050.

  - u. UA has been awarded!
    - i. Oak Ridge Hillside
      - 1. Going to clear the trail corridor and do a large-scale invasive plant removal.
    - ii. ARTP Prairie
      - This site will be restored into a natural prairie as it once was, in collaboration
        with the city and ARTP. This restoration will keep their Baja track alive.
    - iii. Oak Knoll
      - This site will continue its restoration process through controlled burns and fire
        management, that will allow an opportunity for the relic seed bank on the site to
        start restoring some of those genetics.
    - iv. All these projects are funded 100% by an EPA grant.

The Arkansas Union is beginning to incorporate modern sustainability practices into its operations. This is going to mean some changes in the building, with more robust recycling stations and food waste being diverted for composting, among other things.



# Campus Loop







The University of Arkansas campus sits just blocks from the Razorback Regional Greenway—a regional network of over one hundred miles of paved trails.

Unfortunately, the connectivity between the Greenway and campus destinations lacks adequate infrastructure to serve all ages and abilities of users.


The campus needs a contiguous loop of multi-use paved trail to envelope the campus core and allow for efficient transportation and recreation.


